TERMS:

- 1) This Agreement is valid only during 2020 Race Season (March thru Sept).
- 2) Members are responsible to pay dues and have completed all LHCOC required forms.
- 3) The member must remain in good financial standing and comply with club rules and policies. Failure to abide by the Bylaws of Lake Havasu City Outrigger Canoe Club and Racing Team, Inc. (LHCOC) is cause for immediate termination of this Agreement and revocation of membership. If membership is revoked, member will not receive a refund of membership dues paid.

FORMS / RACER REQUIREMENTS:

- 1) Racer must complete all required Club forms:
 - Have completed a current LHCOC Membership form, Waiver and Agreement
 - Acknowledged and initialed Club Rules & Policies, Code of Ethics
 - Completed SCORA Liability & Assumption of Responsibility
 - SCORA Acceptance on-line
 - Racers are required to attend racer related meetings / trainings
 - Attend 2/3 of the required practices (Calendar provided & updated by Coaching staff)
- 2) Physical Requirements:
 - 1) Annual Swim Test completed
 - 2) Huli Drill observation
 - 3) Deep Water Re-entry completed
 - 4) Time Trial for specific seat (when required)
- 3) Racers **MUST NOTIFY** Coach and Racer Coordinator **PRIOR** to racing in any races with other Clubs. This is a safety and liability requirement. Failure to comply could result in disciplinary action and/or suspension.

DUES:

- 1) **A commitment fee of \$20.00 per racer is required at the beginning of the race season (Non-Refundable).**
- 2) Dues do not include race fees; these are an additional responsibility of the paddler.
- 3) Race season dues are to be paid from March thru Sept - as a commitment to the entire practice, race teams and season.
- 4) Dues **MUST** be paid in a timely manner (within 30 days) monthly, quarterly or yearly.
- 5) All dues are requested be paid within two (2) weeks of the 1st of each month.
- 6) All returned checks will be assessed a \$35.00 fee.

Family Membership rates do apply for members with family within their same household (significant other, partner, husband, wife). Initial member pays normal monthly dues and the additional members dues will be \$15.00 monthly. If the additional members are children under 18 (children, stepchildren, grandchildren) living within the same household, dues per child will be \$5.00 monthly.
